**ORDINANCE NO. 414** 

AN ORDINANCE RELATIVE TO CHARGES FOR WATER AND SEWER PURCHASED FROM THE CITY OF JENNINGS, KANSAS. BE IT ORDAINED BY THE GOVERNING

BODY OF THE CITY OF JENNINGS, KAN-

Section 1. The minimum charge for water purchased from the City of Jennings shall be Five Dollars (\$5.00) for each month. The customer shall be entitled to Four Thousand (4000) gallons or any fraction thereof. All gallons over the minimum 4000 gallons shall be charged at a rate of Two Dollars (\$2.00) per each Thousand (1000) gallons.

Section 2. Customer meters shall be read

shall be Four Dollars (\$4.00) for each month that the water service is turned on. Water customers that are not connected to the City sewer lines are not charged for sewer service

shall be made by motion of the City Council and may be changed from time to time. Customers shall be given notice of these changes.
