County tells sheriff to wait for all bids before buying truck

Sheriff Ken Badsky asked Decatur County commissioners about buying a new vehicle again last Tuesday, but they told him to wait until this week, when all the bids are supposed to be in.

At the last meeting, the sheriff and Undersheriff Michael French presented information on a Dodge Durango they found in Illinois for \$22,900 and \$350 for shipping.

The commissioners asked that they get local bids. Commissioner Doyle Brown said Tuesday that he wanted to wait until after the bid deadline.

Sheriff Badsky said he had been talking with Ambulance Director Patrick Pomeroy, who is driving a vehicle that the sheriff's department had taken in a drug seizure. The ambulance department didn't pay anything for the vehicle.

The idea was that the ambulance department could give the sheriff's office some money towards the purchase of a new truck.

Mr. Pomeroy suggested around \$6,000. The commissioners said they wanted to talk with County Attorney Steve Hirsch about that before making any decisions.

Commissioner Ralph Unger said they got a letter from the Kansas Motor Vehicle Division saying that Kansas municipalities aren't allowed to buy a vehicle from a dealer who is not licensed in Kansas.

computers for their classrooms. Superintendent Kelly Glodt said most have never received a new computer. Teachers get old lab computers, he said. With the scheduling and grading programs the district uses, though, teachers have had to use their computers more and more. The laptops would allow teachers to use their computers everywhere. They could take them home and put grades in instead of working in the evenings at the school.

The old computers then can be

The district has computers for teachers anywhere from four to nine years old, he said. Replacement computers don't include computers with the exception of a few teachers, for administration, ranch staff or the non-certified staff

The board received three bids. The first was for 17 Apple computers with three years of payments totaling \$28,477; the second for 20 Toshiba laptops with the total being \$30,780, and the third was for 20 from Dell with the total payment at \$30,549.

The estimated annual payments would be just under \$20,000. Mr. Glodt said they would like to put in

a wireless network for both the grade and high school buildings, which would cost \$10,000 for the equipment.

After three years of leasing the laptops, the district would buy them for \$1 per computer.

Although the board approved the idea of leasing the computers, they didn't decide on a bid.

By taking this step, said Mr. Glodt, the district will have a constant flow of new and updated computers for teachers and classrooms. The money will come from the capital outlay account, which has to be spent for equipment needs and building maintenance.
