Council to lower its taxes

By CYNTHIA HAYNES With an addition here and a subtraction there, the Oberlin City Council came up with a 2005 budget that will lower the property tax levy a little and still provide what the town needs.

At a special meeting last Tuesday night, the council went over a budget that had been hammered out earlier in the month. Most items stayed the same, but between the two meetings, said City Clerk Deanna Castle, she realized that there was \$25,000 that should be in the cash reserve of the bond and interest fund.

Council members decided to leave the money there and take it out of some other part of the budget to keep the tax levy at 67.138 mills, which is what they had decided on at a budget meeting this month.

This year, the levy was 67.896 and in 2003 it was 69.150. Each mill will raise about \$7,000 in taxes.

While the levy won't be finalized until after a public hearing on Thursday, Aug. 19, the council wanted to have the budget ready for publication in today's paper. (The budget is at the bottom of Page 5A.)

After they decided to keep the \$25,000 in the bond fund, the council went over the budget and decided what to cut to make up that amount.

Looking at the capital expenses, Stan McEvoy suggested that, since the city is planning to purchase three new pickup trucks next year, for the cemetery, parks and sewer departments, one might be cut. He asked Supervisor Dan Castle to prioritize.

Mr. Castle said it is difficult to rank the need. Mr. McEvoy was not budging, however, so the foreman said to eliminate the truck for the parks department. Mrs. Castle estimated savings at \$17,000.

After looking over the figures again, Mr. McEvoy suggested cutting the expected health insurance increase from 14 percent to 12 percent — an \$8,000 savings.

Mayor Ken Shobe asked Mr. McEvoy, who sells insurance for a living, if he was comfortable cutting the expected increase. Mr. McEvoy shrugged and said he had no idea what health insurance would cost next year, since the increases fluctuate so wildly.

Expected capital expenses next year will include a new car, lights and computer for the police department; a sand spreader for the street department; a pickup and backhoe lease payment for the cemetery department; a mower for the park department; \$15,000 for a sign for The

Gas tank stopsman in chase

A Colorado man on a 2004 Yamaha motorcycle led a chase that started in Norton, dodged a roadblock near Sappa Creek, roared through Oberlin and ended just short of Rawlins County — when the biker ran out of gas.

Oberlin Police Chief Wade Lockhart said officers were notified around 11:10 p.m. Saturday that a state trooper had tried to stop a man on a motorcycle near Norton, but the man outran them and headed west.

Troopers told the Oberlin Police Department about the man and said he might be heading their way.

Chief Lockhart said Officer Troy Haas and sheriff's reserve Deputy Barry Richards set up a road block about one to two miles east of town on U.S. 36.

The driver, Joel Griffin, 20, of Thornton, Colo., didn't stop, the chief said, but blew right through the roadblock. When he got to town, he turned south and flew down Wilson. Chief Lockhart said he intercepted the bike on Victoria. For a while, he said, it seemed like every street he entered ended with a dead end, but he managed to get away.

Chief Lockhart said Mr. Griffin shot up Penn Avenue and headed west on U.S. 36 with Deputy Richards and Officer Haas on his tail.

The motorcycle ran out of gas just before the Rawlins County line at 11:56 p.m. Officers arrested him for attempting to elude a police officer, reckless driving and driving with a revoked license. Chief Lockhart said he wasn't sure how fast Mr. Griffin was traveling in town, but when he was outrunning the troopers, he was exceeding 120 mph.

Mr. Griffin was being held in Norton County, but will be sent to Decatur County when they are finished with him.

Council will meet Thursday

The Oberlin City Council plans a short meeting at 6:30 p.m. Thursday at The Gateway since it is fair week.

City Administrator Gary Shike said the council needs to talk about sewer plant design. Commissioners agree to buy sheriff new truck

Decatur County commissioners bought the sheriff's department a new truck last Tuesday, approving a \$25,102 bid from Taylor Motors of Colby for a 2004 Dodge Durango.

The search for a new patrol car had stretched out over a month, and the county wound up buying the same truck the sheriff started out with for more money.

The sheriff had wanted to buy a Durango equipped with a police package from an Illinois dealer he found on the Internet for \$22,900 plus \$350 for delivery. Commissioners wanted to know if he'd asked for any local bids, and when they found the answer was no, they sent him back to the drawing boards.

Then the sheriff came in with more bids, but the lowest was from Nebraska, and he said he'd heard that the county wasn't allowed to buy from an out-of-state dealer.

He went looking for more bids. He wound up with two, one from Taylor and one from Tubbs and Sons Ford of Colby for \$26,660 on a 2005 Ford Expedition. Both are four-wheel-drive, four-door sportutility vehicles.

Tubbs offered a \$4,000 trade allowance on a 1997 Expedition the department wants to get rid of. Commissioners found they had one sealed bid for that truck, for \$5,055.55 from Rusty Addleman. They decided to sell to him and to take the low bid from Taylor on the Durango.

The sheriff said it's the same vehicle he wanted to buy earlier. Taylor will get it from Illinois and bring it back, adding about \$1,700 to the cost. On the new truck, \$6,000 will repay the sheriff for an Expedition these come with printers.

Bids were a letdown

County commissioners thought they had four bids for a new sheriff's vehicle last Tuesday, but a couple of the envelopes were sort of disappointing.

Commissioner Pat Glenn opened the four envelopes the clerk's office had collected, and Chairman Ralph Under started to read them.

The first, from Shawnee-Mission Ford, turned out to be an advertising flier, apparently a mass mailing, for a Ford Taurus.
