Sodomy plea gets man 10 years in state prison

sentenced to 10 years in prison after pleading guilty to aggravated criminal sodomy against a 10-yearold boy.

Stanley F. Shimek, a former janitor at the Jennings School, was arrested Feb. 13 on eight counts of feloniously and intentionally engaging in sodomy with a person under 14, a 10-year-old boy. His bond was set at \$100,000.

On Tuesday, Sept. 14, seven months later, Mr. Shimek was sentenced to 10 years in jail, restitution to the family of \$789 and three years of supervision after he is released. With costs and the restitution, Mr. Shimek was ordered to pay \$4,229.

In those seven months, Mr. Shimek's lawyer David Baumgartner asked for an evaluation of Mr. Shimek's competency. The exam was done by High Plains Mental Health of Hays.

In April, Mr. Shimek was found competent to stand trial, but was enrolled in a treatment program designed to establish competency. He was sent to Larned State Security Hospital for a term not to exceed 90 days.

A 37-year-old Jennings man was of jail. He waived his right to a preliminary hearing and plea negotiations started.

> The agreement was if Mr. Shimek would plea guilty to the first count of aggravated sodomy, the other seven would be dropped. There would be no trial.

Mr. Shimek agreed to the plea. Papers filed Monday, Sept. 13, refer to Mr. Shimek as a predatory sex offender. That means he will have to register as a sex offender and provide the state with samples of his blood or saliva for DNA registration

The next day, he was sentenced to prison.

While the question was raised of whether former Jennings Superintendent Lee Stieben knew about the incidents before they were reported to police, Assistant County Attorney Preston Pratt said no charges will be filed against Mr. Stieben. It is questionable as to whether Mr. Stieben knew anything, said Mr. Pratt.

County to pay car bill

The Decatur County commissioners agreed Tuesday that a bill for electrical work on a Ford Expedition the county sold should be sent to the sheriff's office.

Rusty Addleman bought the 1997 Expedition at the end of July, first of August by sending in what turned out to be the only bid for \$5,055. Mr. Addleman told commissioners Tuesday that he was led to believe the vehicle was in good working condition.

When he picked the truck up, though, wires hanging out of the hood. Mr. Addleman said he took it to Ron's Tire. Later he realized there weren't any tail lights and the right headlight didn't work.

Mr. Addleman said he took the vehicle to the Ford dealer in Mc-Cook to have it fixed. When the emergency lights were disconnected, wires were left hanging out the vehicle and other wiring for lights was disturbed. Everything was fixed, he said, and he planned to submit a bill to the sheriff's office.

Then, he said, the check engine light came on. He said he took the truck back to Wagner Ford-Mercury, and they told him the transmission is going out. Mr. Addleman said he has driven the vehicle just 1,000 to 1,500 miles.

The new transmission is going to cost around \$2,500. Mr. Addleman said he talked to the sheriff beforehand and he assured him that it was a good vehicle.

Commissioner Ralph Unger said he remembered a bill for the emergency lights to be removed.
