To do it, the recipient is asked to send money to the writer, in this case \$200. Then a check is sent back for a lot more. Often the writer requests that a large sum of it is sent right back in a check. The check is no good and the person who cashes it can be held liable.

Chief Lockhart said people need to be very careful with such offers, because if it sounds too good to be true, it probably is.

She was also preceded in death by her parents, and an infant son.


