County officials lined up refreshments and a speaker, but only about 20 of 75 township board members showed up for the annual road meeting last Tuesday.

County Clerk Marilyn Horn noted that the attendance was three more than the 17 who showed up last year. Maybe the township officials don't like outside speakers, she

Brandon Mann, a risk manager for the Kansas County Association Multiline Pool, an insurance cooperative, talked to the officials about road signs and safety.

He said the pool, known as KCAMP, has decided to offer insurance for townships and cities this

The pool formed a few years ago, he said, when counties were having trouble finding insurance at any price. Today, it has 59 members "and growing.'

In 2003, he said, the pool paid 162 claims for \$482,000 involving "public works," mostly road and bridge departments. That's only the third-highest number of claims, though; sheriffs are the leaders in claims and payments.

When thinking about insurance, he said, township officials need to think about the total cost of losses, including time spent with the public on claims, higher insurance premiums, negative publicity and problems among employees.

The best thing to do to keep costs down, he said, is to cut the number of claims. Public agencies are good targets for lawsuits, he said, because they have money—deep pockets in

Decatur County commissioners county fair. agreed to go with a local contractor Good Samaritan Center.

Administrator Janice Shobe and maintenance supervisor Lavern Burtis brought in bids from three sources at a meeting last Tuesday.

The low bid came from H&H Construction of Oberlin for custombuilt Mennard Guardian windows for \$17,064. The Good Samaritan organization could get Marvin windows for \$18,639, but with materials to make them fit, the cost would be more than \$30,000, she said.

For installation, H&H bid \$6,000, Wachendorfer Construction \$4,860 and Jim Dowling \$7,089.
