Section One. The rate for all electric current supplied by the city during and after the February, 2006 billing cycle, shall be at the rate of \$0.115 per kilowatt hour with all customers paying an additional charge of \$5 per month per meter.

Section Three. This ordinance shall take effect and be in full force from and after its publication in the official city newspaper.

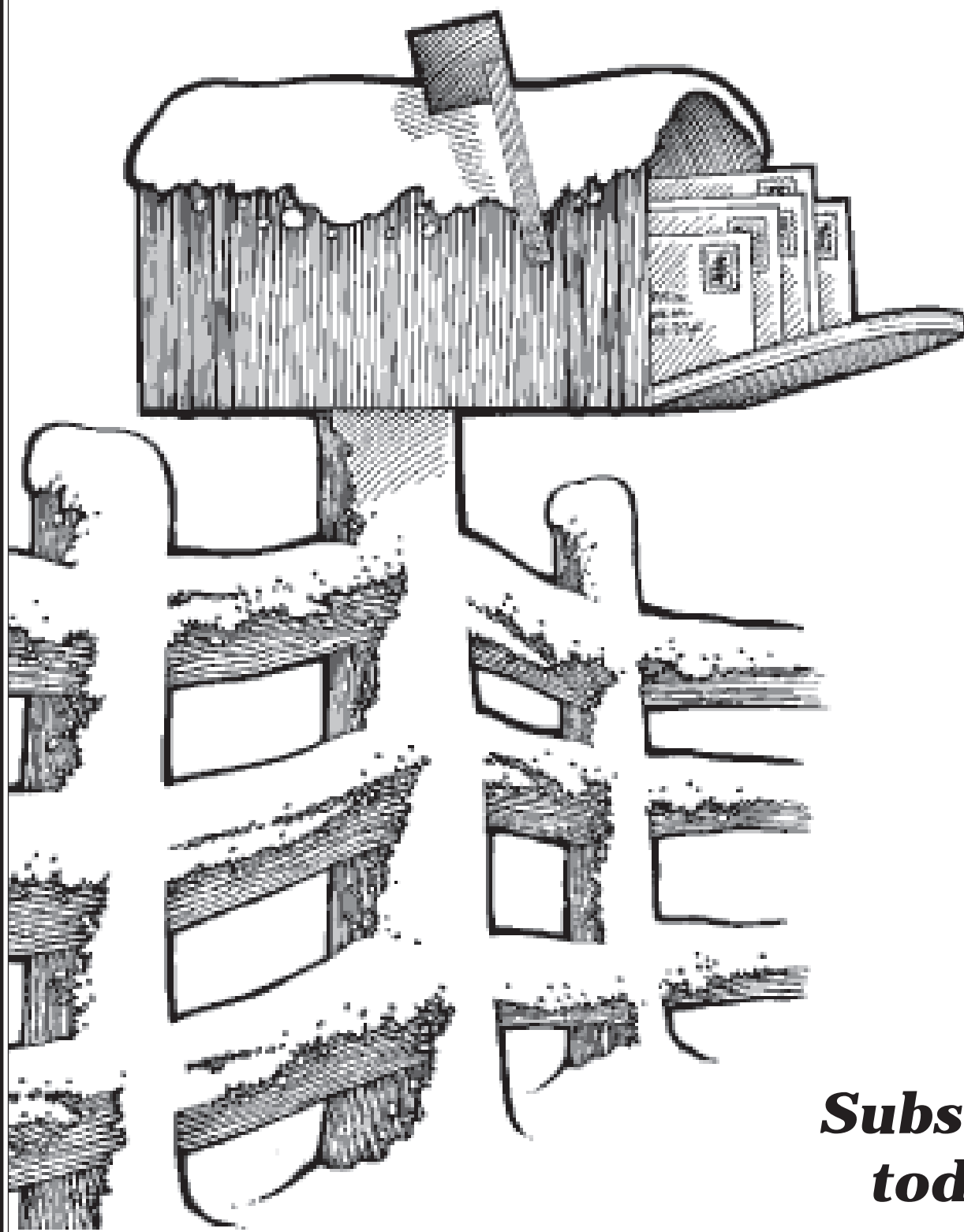
