## County edits new plan

The Decatur County commissioners received copies of the proposed county strategic plan for review last Tuesday.

Connie Grafel, marketing director of the Oberlin-Decatur County Economic Development Corp., said she needs to send the plan to the state Department of Commerce for approval, but wanted the commissioners to look at it first.

Most of the information in the plan was taken from the Kansas Communities workshop at the high school and the action teams that have been set up through that group. Down the road, said Ms. Grafel,

they might have a hard time finding people for leadership positions on the economic development corporation. She said she isn't sure why.

The plan has to be updated every five years and if it is approved then it will allow for tax credits to be given to companies that provides jobs, including the new bus company in Jennings. It would make the county a designated non-metropolitan business region, if everything is approved.

Tim Stallman, road and bridge supervisor, asked the commissioners for authority to purchase tires for all equipment to restock their inventory. Mr. Stallman said he hasn't gotten all of the prices.

Martin Tractor, out of Colby, will hold a demonstration on the Sappa Creek Road near the Zander place about two miles west of town today for the global positioning system. Mr. Stallman said the area will be mowed.

## Jail adopts state idea

The assistant emergency preparedness director talked with the Decatur County commissioners Tuesday, Aug. 8, about buying inmate prescriptions on the state plan. Patti Skubal, a part-time sheriff's

deputy who also works on emergency planning, said it is a big savings for the jail budget to get the prescriptions the inmates need through the state plan. She said it was required earlier and it is up and running here now. All of the prescriptions are purchased locally, but the jail gets a discount just like a prescription card. This is a savings for the county and taxpayer, said Sheriff Ken Badsky. Commissioner Doyle Brown said he attended a meeting about the prescription plan and thought it was for the bigger jails. County Attorney Steve Hirsch said the plan isn't required, it is only suggested. Mrs. Skubal said she would bring in the information. Commissioner Ralph Unger said he doesn't want to take away business from the local pharmacies or hospital. Brenda Arnold is working on a weapons of mass destruction emergency operation planning course at The Gateway starting Friday, Nov. 3 and ending Sunday, Nov. 5. It will be a three day course. The Kansas Department of Transportation will be paying for the meeting site and meals through a grant.


