ORDINANCE NO. 421

AN ORDINANCE PROHIBITING OPEN BURNING WITHIN THE CITY LIMITS OF JENNINGS, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF JENNINGS, KAN-

Section 1: It shall be unlawful for any person to burn rubbish, tree limbs, trash, paper, cartons, boxes, barrels, wood or any other combustible material within the city limits of Jennings, Kansas, unless the burning is otherwise approved by the Kansas Department of Health and Environment. These restrictions shall not apply to residential fireplaces or charcoal burners or broilers used in preparation of food

Section 2: The penalty for violation of this ordinance shall be a fine of up to \$500.

Section 3: Leaves and garden debris may be burned within the city limits of Jennings. Kansas, at specific times designated by motion of the City Council.

Section 4: All ordinances or parts thereof in conflict herewith are hereby repealed insofar

Section 5: This ordinance shall take effect and be in force from and after passage and publication in the official city newspaper


