Here are tips for better pasta

Pasta is a dinnertime favorite. mixed in casseroles or covered with sauce. Often these dishes could taste even better, though.

Try more variety in pasta shape, ingredients and sauces. Cooking pasta as the Italians do - al dente. which means firm to the bite or chewy – can improve its taste, too.

Matching a new pasta shape to an appropriate sauce largely comes down to pasta size and sauce thickness. Try the following recommendations:

· For thick sauces, use thicker pastas, such as fettuccine and lasagna. • Pair chunky sauces with sturdy

shapes, such as fusilli (twists), farfalle (bow ties), macaroni or ziti. • Match smooth, thin sauces with

the thinner strands of pasta - vermicelli and spaghetti.

Like traditional pasta, wholegrain pasta is high in complex car-

ber in traditional pasta. It's definitely worth a try.

To taste as it should, pasta needs to cook in boiling water – lots of it. Cooks get into trouble with that because they're afraid the pot will boil over after they put in the pasta and bring the water back to a boil, so they start out with less water or turn down the heat.

Using a pot just one size larger will often take care of both problems. It won't be as likely to boil bohydrates plus it adds a bit of the over, even though its larger quantity richness of a whole-grain taste. of water will actually heat up again Also, a half cup of whole-wheat more quickly. Using 4 quarts of pasta has about 3 grams of fiber water per pound of pasta also dilutes compared with about 1 gram of fi- the starch released during cooking,

so the end result isn't sticky.

Follow package directions so you don't cook the pasta too long. When done, rinse the pasta in cold water to stop the cooking process. Remember: Italians like pasta cooked "to the tooth"-which means tender but still slightly firm, never mushy or soft.


