# City could take state tax refunds for old utility bills

The Oberlin City Council approved adding an administrative fee to debts owed for utilities and file them with the state so the city can get its money from income tax refunds.

City Administrator Gary Shike said at a meeting Monday that the recommendation came from City Clerk Deanna Castle, who learned about the option at a meeting. When someone moves without paying a utility bill, he said, it can be sent to a state offset program. That debt will then be "offset" from the person's state income tax refund, if any.

The state takes 20 percent of that debt as a collection fee, he said. The city can add an administrative fee of 20 percent and then get the full amount of the debt repaid.

The council also approved a building permit for Dale's Fish 'N' Fun without a survey for storage units to be added at the store on U.S. 36 now.

Mr. Shike said owner Dale Young applied for the permit. The city's permits require a survey for anything that costs \$2,500 or more.

Mr. Young and co-owner Joe Dejmal talked to City Attorney Steve Hirsch about the permit, and said he told them the code allows the survey requirement to be deferred to the council.

# **Council may make** contractor pay up for unfinished work

Although the city's new waste water treatment plant is in operation, it isn't done, and the Oberlin City Council talked Monday about charging liquidated damages to the contractors because they missed the completion date.

Contractor Midlands Contracting, said City Administrator Gary Shike, was supposed to have the facility done by the end of November, but got an extension for six months to May. The new lagoons south of Sappa Creek aren't completed, he said, and the sludge hasn't been removed from the old ponds.

At a meeting last Monday, said Mr. Shike, the council asked about six-month extension on a Commucharging damages for the contractors being late.

Both Chris Miller, owner of Miller and Associates, the engineering firm which designed the plant, and City Attorney Steve Hirsch said the project needs to be finished before they assess any liquidated damages. A letter has been written, said Mr. Shike, and sent to Midlands.

The problem, he said, is that items from the original contract aren't done. The items like a taller fence that was just added aren't done either, but that is understandable.

Mr. Shike said the council members were upset to varying degrees that the plant isn't done.

The council agreed to request a nity Development Block Grant for \$400,000 for the plant which has to be used by Sunday. The last payment won't be done by then, said Mr. Shike. He said this extension is the only time the city can request.
