On October 18, 2007, an application was filed with the Federal Communications Commission seeking authority to modify the construction permit of FM radio station KRLE to change the station's community of license from Oberlin, Kansas to Carbon Hill, Alabama and to operate a Class C1 FM broadcast station. 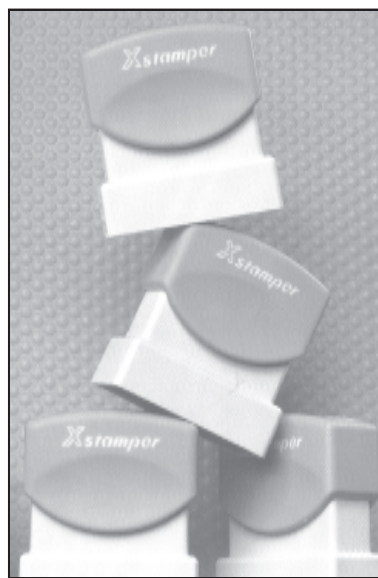

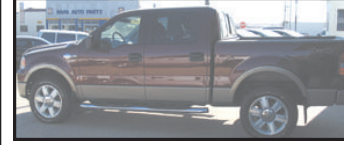

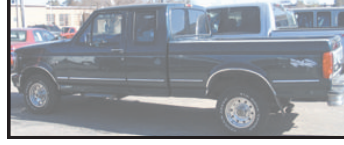
