

aheintz@nwkansas.com Some northwest Kansas farmers may be able to sell water rights to the state under a program designed to stretch out the area's water supenough water downstream to Nebraska.

Landowners who are willing to retire their water rights may be able to sell them to the state Conservation Commission at a fixed rate price of \$2,000 per acre foot under the Water Rights Retirement Program, known was WTAP or "Water-TAP."

For example, he said, a person who wants to retire a well that is near a stream would be given preference over a person who wants to sell a well that is located far away from a stream, even if that person will accept less money.

"We want to evaluate all the variables and decide what gives us the best bang for our buck," Scott said.

There is only so much money, he added, and some people who want to retire their rights will not be able to sell.

He said the people who retire their water rights would be able to practice dryland farming. Some might sell only part of their rights, not all, and continue some irrigation.

The project will last five years. The fall sign-up period will go through Nov. 15. If money is still available, the commission will have a spring sign-up period Feb. 15 through March 31.

## **County raises** equipment rates to cover costs

The Decatur County commissioners agreed last Tuesday to raise the hourly rates on road and bridge equipment to help cover rising costs.

The county raised the rates for the equipment in 2006, three years ago, said Road and Bridge Supervisor Tim Stallman. Diesel fuel is up, said Mr. Stallman, road and bridge supervisor, as are other costs.

The increases, he said, are 15 to 25 percent, depending on the machine.

Labor and fuel costs have both gone up in the past three years, said Commissioner Ralph Unger. So has insurance, noted Commissioner Stan McEvoy.

There are a few rates that stayed the same, said Mr. Stallman.

The commissioners looked over the proposed numbers and approved them. Mr. Stallman said he wants the prices retroactive to Wednesday, Oct. 1, since the townships are billed quarterly and that's the start of the fourth quarter.

### Council to offer guard lease

The Oberlin City Council agreed last Wednesday to offer a 99-year lease at \$1 a year to the Kansas National Guard for the former youth ranch at Sappa Park, including the buildings

Councilwoman Marcia Lohoefener said the council needed to make a decision about what kind of offer the city might make in case the National Guard is interested.

Councilman Jay Anderson said he thought a lease for 99 years at \$1 a year might be a sale clincher.

What does the city currently owe on the ranch? asked Mayor Joe Stanley. Councilwoman Rhonda May said she thinks the debt is in the neighborhood of \$115,000 to \$120,000.

Lt. Col. Eric Peck, with the National Guard has looked at the area, said Mrs. Lohoefener. What's out there is usable.

So far, said Ms. May, the city hasn't been very successful in figuring out what to do with the land and buildings at the former ranch. It is a usable and valuable property to someone, she said, but the city just hasn't found that person. A longterm offer to the National Guard would be a benefit to the community and the county.

The National Guard did say they wanted a long-term lease, said Mrs. Lohoefener.

Dr. Anderson proposed the city offer the buildings and 15 acres surrounding them to the Guard for a 99 year lease at \$1 a year. Ms. May seconded the motion.

The vote passed 4-1, with Councilman Rob McFee voting against. He said he isn't against the National Guard using the area, but he thinks the city should get more than \$1 a year.
