During school Logan has worked at the Decatur County Feedlot. Logan's favorite quote is "When the going gets tough, the tough get going.'


Logan's advice for the underclassmen is to work your hardest and have absolutely no regrets.

Seated as second chairs were Katie, trombone; Nolan, trumpet; and Tim. drums.

All six bands practiced for two days, and then on Sunday they performed a concert. Thirteen scholarships were also awarded, and Chris Larson was awarded the Outstanding Musician Scholarship.

'Our kids did amazing," said band director Sarah Bricker. "We dominated on solos in the band."
