37) HOTEL: Abuilding occupied or used as a more or less temporary abiding place of individuals or groups of individuals who are lodged, with or without meals, and in which there are more than twelve sleeping rooms.

Section 3. Effective Date. This ordinance shall take effect and be in force from and after its publication in the official city newspaper.
