**Oberlin City Council** backs out of software deal

c.haynes@nwkansas.com The Oberlin City Council decided Thursday to back out of a deal it had made for computer software for utility billing and city bookkeeping and go with a different company.

During the last meeting on Feb. 19, City Administrator Austin Gilley asked the council to drop an agreement, made in November, before he began work, for Munisoft. It was provided by Computer Business Systems out of Phillipsburg, for software to run the city's payroll, utility billing and fund accounting systems because it was difficult to use and outdated.

However, Mr. Austin invited the program's designer and owner to speak. Ken Artz told the council that the city has had hardware problems and that his company has provided a lot of support services.

Mr. McFee that the Munisoft system was not user friendly.

The council agreed to pay Mr. Artz for his time, since he did visit Oberlin several times and spent many hours on the phone trying to solve problems.

In other business, the council: • Passed an ordinance to stop anyone from building a wind-powered electrical generating unit or tower within the city limits, with Councilman Rob McFee voting no.

• Heard that the bacteria in the city sewer lagoons, the stuff that keeps them from smelling, has been revved up with the use of aeration.

• Discussed whether department heads should attend city meetings since that could lead to additional overtime.
