The Oberlin City Council will receive information about six to seven allegedly blighted properties from the city administrator when it meets Thursday at The Gateway.

Administrator Austin Gilley said he's had a few complaints about some of the properties they will discuss. Some of the properties have people living in them, he added. Mostly, the complaints are about the house itself, he noted, not the yard or how it is kept.




