# Vandals strike at equipment parked by roads

Someone is vandalizing Decatur County's equipment while it's parked out along the county roads.

The commissioners decided last Tuesday to offer a reward to anyone who can lead them to the arrest and conviction of the person or people responsible for the damage.

Someone broke some windows and lights on a grader parked at Rock Hill, in the Traer area, said Road and Bridge Supervisor Tim Stallman. A broken beer bottle was also found in the area.

He added that this has happened before, to the same grader.

Undersheriff Allen Marcum has been to the scene and investigated, he said.

The road grader, a 2001 Caterpillar, is back in town to get fixed, said Mr. Stallman. It will probably cost around \$400 just for the materials. That doesn't include the cost for the labor to fix it or to go pick up the grader.

Commissioner Ralph Unger said he's noticed more signs being shot at on the county roads. In some places, he said, if the vandal missed the sign, they could easily hit a farmstead.

Maybe the county could offer a reward and run an ad in the newspaper, said Commissioner Stan McEvov.

It would be good idea for the equipment and the signs, said Mr. Unger. (The ad appears on Page 3B of today's Oberlin Herald.)

Mr. Stallman said he talked with Dan Grafel, with D&S Grain, who said the county could park graders with his trucks.

On another issue, Mr. Stallman said an engineer with Penco condemned one of the off-system bridges. The county has a contract with Penco to inspect the bridges on the township roads every other year.

The condemned structure is a two-span wood bridge on the north used dozers for sale in the Country side of Sid Metcalf's farm, which Advocate and another publication.

The Guaranteed Loan Program, run by the U.S. Farm Service Agen- Loan Program for those unable to cy, has increased its loan limit to obtain financing from commercial \$1,112,000, effective immediately, based on the "Prices Paid to Farmers Index."


