The vehicle, he said, has 12,000 miles on it and other than a few minor scratches on the rear bumper from getting items in and out, it looks brand new.

The Jeep Cherokee Sport is burgundy, said Mr. Unger. If it's not something that will work, he said, that's OK, but he put a hold on it just in case.
