Section One. BILL; PAYABLE.

That all bills for furnishing utilities by the city shall become due and payable on the first

day of each month. If payment is not received by the 15th of the month, five (5) percent of the The Stamps

amount owed shall be added to the amount originally payable; and unless such bills are paid on or before the 15th day of each month service shall be discontinued as provided herein. All bills are payable to the city clerk's office. No monies are to be collected by the electric department or other city staff Section Two. NOTICE: HEARING.

(a) A delinquency and termination notice shall be issued by the city clerk on or after the 16th day of the month when the account has not been paid. It shall be mailed to the customer at his or her last known address (b) The notice shall state:

(1) The amount due, plus late payment

(2) Notice that service will be terminated if the amount due is not paid within seven days rom the date of the notice;

(3) Notice that the customer has the right to a hearing before the governing body prior services being terminated;

(4) Notice that the request for a hearing must be in writing and filed with the city clerk no later than the date proposed for termination

(c) Upon receipt of a request for hearing, the city clerk shall advise the customer of the date, time and place of the hearing which shall be held at the next regularly scheduled city council meeting. At the hearing the city council may extend the date for payment and extend the time of termination of service for good cause shown.


