## Self-taught artist recognized for work

Janetta Evins, St. Francis, was recognized Sunday for her years of producing paintings, sketches, poetry and prose of Cheyenne County. Two volumes of her work have been produced by Dorthy Mast and Rosemary Powell through a Kansas Art Commission grant.

The Cheyenne County Historical Society hosted the presentation and a reception at the Cheyenne County Museum, St. Francis, following the presentation of the volumes to Mrs. Evins.

The program was opened with Tobe Zweygardt, long-time friend, introducing Mrs. Evins. Mrs. Mast then took the stand and told how Mrs. Evins was a selftaught artist and about two years ago, she and Mrs. Powell became aware of the history her paintings and sketches depicted. They began collecting data and pictures of the paintings and had long discussions with Mrs. Evins.

They had applied for a grant through Southwestern Bell to purchase the needed computer, printer and scanner but that grant was put on hold.
