## Logan downs Oberlin



The Decatur Community High girls basketball team fell 50-40 to the Logan Trojans last Tuesday in Oberlin.

Logan started off ahead, outscoring Oberlin 14-9 in the first quarter and added to their lead in the second by outscoring the Lady Red Devils 19-11 to lead 33-20 at the half.

In the third quarter, both teams scored 7 and in the fourth, Oberlin hit for 13 while Logan had 10 points.

Scoring were Alexis Hissong, 15 including three three-point shots; Miki Dorshorst, 11 including a three pointer; Darbi Rouse, 5; Brianna Klima, 4; Demi Murray, 3; and Hannah May, 2.

Hissong also led in rebounds with seven, followed by Klima, 6; Shawn Baker, 4; Murray, 3; Rouse, 2; and May and Kariah Castle, 1 each. Hissong had the team's only blocked shot. Rouse and Dorshorst each had three steals, while Klima and Baker had one each.

The Oberlin girls hit eight of 13 from the free throw line for 62 percent.

The Oberlin junior varsity lost 39-12. Logan outscored Oberlin 10-7 in the first quarter, 18 to 2 in the second
