2001, then he moved to Oberlin. He married Mary (Fortin) Uehlin in Oberlin, where they continued to live. She preceded him in death on Nov. 6, 2010.

He attended Cliff-Dale rural school and graduated from Decatur Community High School in 1943. He served in the 346th Infantry of the 87th Division in World War II and was wounded in the Battle of the Bulge. After his discharge, he farmed for a time with his father.

He attended North Park College in Chicago, earning an Associate of Arts degree. He later earned a Bachelor of Arts from Bethany College in Lindsborg.

He married Ruth Lundberg on Aug. 11, 1951, in Norway, Mich. After completing seminary in 1953 at North Park College and being ordained, he and his wife were consecrated to serve as Covenant missionaries to the Congo. He was an evangelist, pastor and teacher of young men in Bible Schools, the Bible Institute and seminary. He and his wife received the Medal of Civil Merit from the government for service in the Congo.
