(Continued from Page 1A) errors. There were some contested ballots we couldn't allow because they moved or weren't registered, but there weren't very many, and it wouldn't have made a difference on any of the races."

Overall, Mr. Unger said, this year's canvass was routine, with no errors or surprises.

"It was all pretty standard procedure," he said.

All three questions on the ballot passed with flying colors here in Decatur County:

• A state constitutional amendment allowing the Legislature to decide how to tax watercraft passed 790 to 529.

• The county dairy question, on whether the county should allow corporate-owned dairies, passed 1,038 to 394.

• The City of Oberlin said "yes" to a 1.5 percent sales tax increase to pay for construction of a new swimming pool, 567-311.

Decatur County favored Mitt Romney as commander-in-chief with 1,218 votes to Barack Obama's 266. Libertarian Gary Johnson came in third with 42 votes and Reform Party candidate Chuck Baldwin was last with 6.

Republican Tim Huelskamp, unopposed to retain his position as U.S. representative, drew 1,284 votes in Decatur County. Republiposition as a state senator in District 40, drew 1,154 votes to Democratic

Sen. Allen Schmidt's 328. State Rep. Ward Cassidy of St. Francis, who ran unopposed, landed 1,349 votes here.

Republican Preston Pratt had 1,325 votes to remain district judge, and newcomer Jay Tate ran unopposed for the position of district magistrate judge, for which he earned 1,346 votes. Nancy Moritz, a Kansas Supreme Court justice, staved in her position with 870 "yes" votes to 375 "no" votes.

Also keeping their positions on a yes or no vote were state Court of Appeals judges Steve Leben (895 to 313), G. Joseph Pierron, Jr. (907 to 294), David Bruns (907 to 279). G. Gordon Atcheson (858 to 317), Karen Arnold-Burger (840 to 339) and Richard Greene (849 to 305).

Republican Sid Metcalf was uncontested for the position of county commissioner for District 2. He drew 432 votes. The race for District 3 commissioner saw a three-way contest, with write-in candidate Robert Jones getting 93 votes, Democrat Brad Long 67 and Republican winner Brad Marcuson 374.

Other uncontested county positions included County Clerk Colleen Geihsler (1,373 votes), Treasurer Jean Ann Hale (1,347), County Attorney Steven Hirsch (1,254), Sheriff Ken Badsky(1,258)and Register of Deeds Kari Ketterl can Ralph Ostmeyer, who kept his (1,376), all running on the Republican ticket.

## County seeks helpers

sdecamp@nwkansas.com Only one person has applied to fill one of the 15 openings on Decatur County boards for next year, commissioners heard at their meeting last Tuesday.

The openings include two spots on the fair board, two on the hospital board, two for the mental health board, two for the health foundation. one for the health department advisory board and five for the summer recreation board.

The one person who had applied for a position on the fair board, said Commissioner Stan McEvoy, was Brent Stallman, who did so "after a little arm twisting."

Mr. McEvoy said so many positions are available because current members are either deciding to step down or those holding the seats have served their allotted time. If a current board member wishes to maintain their position, he said, they still need to reapply for next year.

"For them to apply," Mr. McEvoy said, "they need to pick up an application from the (county) clerk's office, whether they're reapplying or a first-time applicant. We need people ... to step up and serve on these boards. It's very important for our boards to keep active and keep people on them ....

"It's not always a very thankful job, but it's a very necessary one. It would be nice to see some of the younger people step up and serve, too. They have a vested interest in our community as well."

Mr. McEvoy said that if the jobs aren't filled, the commissioners will have to "go out and twist arms," and they'd rather not have to pressure people into the jobs.

### **Townships see** ties in election

sdecamp@nwkansas.com The Decatur County townships ran into a unique problem in this election, county officials said. Many of those elected as either trustee or treasurer were write-in candidates who already held a job on the township board, excluding them from being able to hold their new position simultaneously.

County Clerk Colleen Geihsler, who serves as county election officer, said Sherman Township had ties for trustee and treasurer. Normally, if those candidates are not already on the township board, a coin toss is done to determine the winner. However, she said, in both cases the elected and write-in candidates were already members of the township board, so a simple reshuffling can take place over the next week after they determine who, exactly, wants which job. In Dresden Township, all six candidates were written in, and the same two people tied for both positions. Gary Ritter and Linda Schroer both got five votes to be trustee and two votes to be treasurer. Ms. Geihsler said she could not confirm the results, as she was out of the office on Veterans Day, when this report was being made, but said that Jay Wessel, also written in for treasurer with two votes, was going to decline the position, as he is moving out of the township. If Steve Ritter, also a write-in candidate for treasurer with two votes, declines his position too, then it will be up to Mr. Ritter and Mrs. Schroer as to who will take which position. Ms. Geihsler stressed that these decisions had not been made, but seemed very likely to resolve themselves in the coming week. In Sherman Township, there were four write-in candidates with one vote each, said Ms. Geihsler. Larry Roe is likely to take the treasurer position, as his opponent, Brad Uehlin, is the township clerk and cannot have both jobs. This would leave Phil Wurm as the only candidate for trustee, as L. Roe was the other candidate written in for that position as well. Again, Ms. Geihsler said that normally these problems would be solved with a coin toss, but considering the fact that most candidates already hold or are otherwise uninterested in the positions, she said, it's likely that the conflicts will sort themselves out. In one of the few actual contests on the ballot, Jennings Township elected Republican Denise Ritter as trustee with 39 votes over Democratic contender Roberta Petracek, who had 31. Duwayne Metz became treasurer with 63 votes.

In other townships, most candidates for township office either ran unopposed or against write-in candidates:

• In Allison, Rebecca Wahlmeier was voted in as trustee with 11 votes and Linda Wahlmeier as treasurer with 13.

• For Altory, Jeannie Gawith had 12 votes for trustee and her husband, Gary Gawith, got 11 for treasurer. Our townships are so small, that in a lot of cases this happens, said Ms. Geihsler, so there is no conflict of interest

• In Bassettville, Steve Brown as trustee got 12 votes and Terry Lippelmann as treasurer had 10.

• Beaver elected Jay Ketterl as trustee with 26 votes and Jacob Weyeneth as treasurer with 24.

Members of the Decatur County Fair Foundation board met with county commissioners to report on their financial standing and discuss planned improvements at the fairgrounds.

The foundation helps to raise tax-deductible donations for improvements at the fairground while the county Fair Board runs the fair. Members said that their biggest project right now in planned improvements to the livestock building.

County Treasurer Jean Ann Hale said at the meeting Oct. 23 that the foundation has \$11,935 in its savings account and \$733 in checking. \$8,299 of that is earmarked for the livestock building, she said, leaving \$4,368 for other improvements.

Aside from the livestock building, President Robert May said that the foundation hopes to fix up the open-class building, put fencing around the beer garden behind the grandstands and build a new ticket booth and offices that can serve as • In Lyon, J. > To do all this, however, they will need to raise more money through public donations and gifts from wills. Because the board is just now starting to get bids on the work, he said, the members are not sure yet how much they need to raise.

> "We'll see how much we can do it for," said Mr. May, "or if we want to postpone it a year, or do what we can with what we have. It may take two or three years to phase in."

> If you would like to donate to the effort, he said, makes checks payable to Decatur County Fair Foundation, and bring them either to the county clerk's office or mail them to the treasurer's office at Box 167, Oberlin, Kan. 67749. Donations should be tax-deductible.

> The foundation typically meets with commissioners every quarter, Mr. May said, but has not since the fair. He said the members should be back sometime in January.
