

Grandstand entertainment set for the fair

What has four wheels and likes to play in the mud? The grandstand entertainment for this year's Decatur County Fair, that's what.

Kicking off the grandstand shows at 8 p.m., Thursday, Aug. 8 will be a Tough Trucks competition. If you think your truck can make the grade and you can navigate the obstacle course faster than anyone else, this is the event for you. Cash prizes will be awarded.

An entry fee of \$35 will gain entrance for you, your truck and one pit person. Pit passes are \$25 per person. If you want to pre-register your truck, call the Decatur County Extension office at (785) 475-8121 or just show up at the gate that night.

It's Demo Derby time at 8 p.m., Friday, Aug. 9. Entry fees are \$50 which includes the car, driver and one pit person. Pit passes will be the same as for the Tough Trucks competition, \$25

per person. There will be two classes of vehicles, 4-cylinder and 6-cylinder. There will definitely be three heats of eight cars each and four heats if enough vehicles register. Cash prizes will be awarded.

A mud volleyball tournament is scheduled for the last day of the fair at noon in front of the grandstands. Each team must pay an entry fee of \$60 or \$10 per person. The entry fee will include a free T-shirt. Call the Extension office to register your team. The deadline to sign up a team is this Friday.

There will be one hard and fast rule for the mud volleyball teams; there must be a girl on the "court" at all times.

Grandstand prices for all three shows are: \$10 for adults; \$5 for children ages 6 to 10; and children 5-years old and younger are free. All proceeds go to the Decatur County Fair Board.
