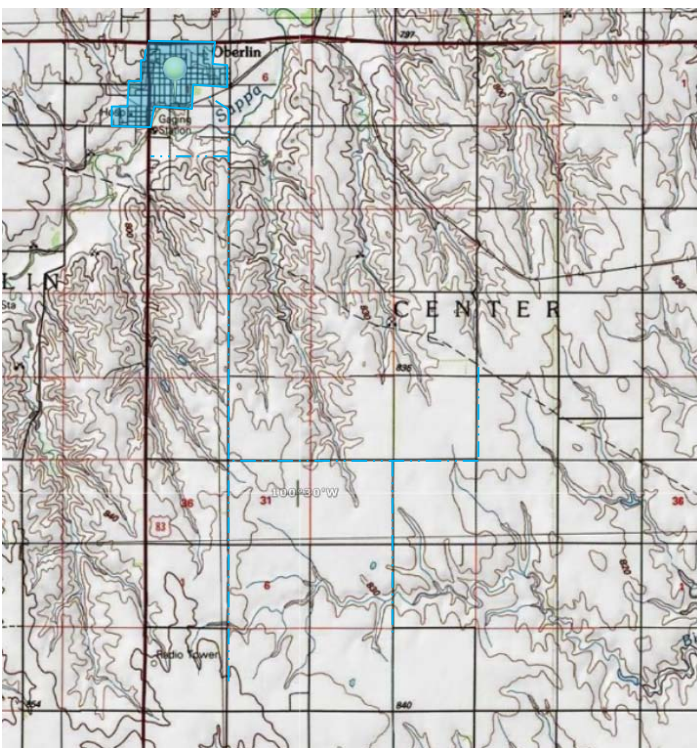

Notice of the Availability of an Environmental Assessment The USDA, Rural Utilities Service has received an application for financial assistance from City of Oberlin. As required by the National Environmental Policy Act, The Rural Utilities Service has prepared an Environmental Assessment that evaluated the potential environmental effects and consequences of the proposed project. This notice announces the availability of the Environmental Assessment for public review and comment.

The proposed project consists of the construction of a new water treatment facility, ground level storage tank, transmission mains, water wells, and water distribution improvements; including information regarding any conversion(s) of any important farmland, wetland, floodplain or have an adverse effect to a cultural resource. Mitigation measures for the project include a National Pollutant Discharge Elimination System (NPDES) Permit and a Construction Stormwater General Permit. The alternatives considered to the proposed project include: a centralized treatment facility or a new drinking water source.
