(Continued from Page 1A) and Mr. Lotker. The owner was Bill Collins, who also showed them a beautiful merry-go-round, which he said was his prize ride.

So the 40-foot Ferris wheel was purchased and a story in The Ober*lin Herald* stated, "This community is to have a home-owned carnival, and if plans of the newly-incorporated Decatur County Amusement Authority work out, there will be a Ferris wheel, at least two kiddie rides and about a dozen concessions ready to use by county fair time this summer,'

After the fair, the amusement board met and decided they needed to try to get more ideas and expand the carnival for next year. Mr. Lotker said that when he and his wife, Dottie, went to Wichita to visit their son, his wife knew about Chance Manufacturing Company and made an appointment for them to view their rides. He showed them a Looper ride and offered it to them for \$2,500, lock stock and barrel, which was an unbelievable price, Mr. Lotker said.

The ride was brought home by a tractor furnished by Hamilton's Oil Company and their driver, Gordon Railsback.

Then Mr. Lotker reported that another ride was in the making for use the following summer. Bill Matchett of Matchett Welding had a swing on the drawing board. Blueprints were ordered and Mr. Matchett expanded on them and completed the swing as his winter project.

"We want this to be everybody's carnival," said President Lotker," as he announced that contributions would be sought to purchase molded fiberglas chairs for the new swing ride.

By 1975, the home-owned carnival offered Ric-a-sha, Cream Can and Bingo concessions, along with basketball throw, goblet toss, during the 1980 fair and over 5,000

duck pond, roulette wheel, dart toss, Pepsi throw and cane toss. Bill and Ann Ooton and Sally Henningson went to Kansas City to choose prizes for the concessions. A new fund was started to buy a cotton candy machine.

In January 1976, the Kansas State Court of Tax Appeals ruled that the Decatur County carnival would now be exempt from property tax, following approval of county commissioners.

"Decatur County Amusement Authority is boasting the realization of adding a 30-horse merry-goround to their home-owned carnival," wrote Connie Grafel in the April 1976 edition of *The Oberlin* Herald."The unit has been donated to the citizens of Decatur County by Ward Sauvage and will be in operation by fair time."


Mr. Lotker recalled, "One day Dottie and I were sitting down for dinner when the phone rang and Ward Sauvage said, "Floyd, can you buy me a merry-go-round?"

"I about fell out of my chair but managed to tell him, "Yes, I know of a merry-go-round that I think would be very great for our carnival."

Mr. Lotker said he recalled the beautiful merry-go-round they had seen in Minneapolis when they bought the Ferris wheel, so he contacted Mr. Collins and arrangements were made for the purchase of the ride. Mr. Sauvage furnished a tractor and driver, James Boettger, and the ride was brought to Oberlin.

Another exciting part of the home-owned carnival was the donation of a train by Harry and Betty Schrammel. With volunteers from all over the county, new rails and track were ordered and laid with the completion and dedication planned for the first night of the fair.

Governor John Carlin was invited to speak at the dedication of the train

Moisture brings hopefor forcorn

With the recent rain and weather conditions, the corn fields in Oberlin and surrounding areas look a little more promising.

Hansen-Mueller Grain Manager Joe Deraus said even though the rains last week were small, the cooler temperatures afterwards seemed to help preserve the moisture.

"I heard reports, he said, "of areas in Oberlin and McCook receiving a quarter inch of rain and Cedar Bluffs receiving half an inch."

The corn fields at Norcatur are not doing as well. They didn't receive any significant amounts of rains like Oberlin and Cedar Bluffs did last week, he said.

Mr. Deraus said the conditions of the corn fields around Oberlin vary.

"The heat during the wheat harvest has taken its toll on the corn harvest as well," he said. "If we continue to get small rains, I think it's going to be a good harvest."

Dan Grafel, a farmer from Traer and co-owner of D&S Grain, said some areas around town received as much as three inches of rain.

'We have not had any rain prior to the rains we had last week," he said. 'Since the rains, pastures around Traer have improved and some of the corn that hadn't been completely burned has started turning green again."

Mr. Grafel said the corn fields that were barely irrigated have also improved after the rain.

"I think harvest will be later than expected," he said, "but harvest will be decent."






